Collaboration and Mutuality: San Jose’s Mayor’s Gang Prevention Task Force, The “San Jose Way”

The City of San Jose’s, Mayor’s Gang Prevention Task Force (MGPTF), is a long standing comprehensive Youth Violence Prevention Initiative that serves youth and young adults ages 6-25. This collaborative model was formed in 1991 to address the increased gang-related violence that was occurring throughout the community. The MGPTF is a broad coalition of stakeholders comprised of: local residents; the City of San Jose; the County of Santa Clara; State government leaders; school administrators and officials; community and faith-based organizations; and local law enforcement. The MGPTF brings together this diverse partnership to better leverage each group’s expertise and resources as part of a coordinated, interagency effort to address gang-related activity in San Jose. The MGPTF was also part of the National Forum for Youth Violence Prevention under the Obama Administration. The webinar will focus on the structure of the MGPTF, its programs and partners, and strategies we have used to align resources to meet program goals and outcomes. Presenter Bio

Mario Maciel

Mr. Mario Maciel is the Division Manager of the City of San Jose’s, Mayor’s Gang Prevention Task Force (MGPTF). He received his Bachelor’s Degree from San Jose State University and began his career working with high-risk youth in drug and alcohol programs in 1993. In 1995, he began working for the Mayor’s Gang Prevention Task Force, managing the Clean Slate Tattoo Removal Program – which focuses on removing gang related visible tattoos. During his tenure with the MGPTF he has steered the initiative to ensure that it remains relevant, flexible and responsive to the community needs. As the Division Manager, Mr. Maciel is responsible for a comprehensive strategy that provides youth intervention services through a multitude of internal programs; oversees the granting of \$2 million dollars annually to community based organizations that provide services; and manages the neighborhood services unit that addresses community issues in designated gang hotspot areas. Through his leadership, the MGPTF has incorporated innovative approaches to delivering services for high-risk, gang-impacted and gang-involved youth and young adults. While he has worked for over 24 years in youth violence prevention programs, his dedication to serving this population has been and continues to be his guiding force to ensuring that the programs and services offered through the Mayor’s Gang Prevention Task Force continue to strive for excellence. Mario is a long-time resident of Santa Clara County, where he resides with his wife and two children.

Peer Support: Creative Approaches to Safe Streets and Developing Community Self-Determination - William Kellibrew discussed the creative approaches being implemented by the Baltimore Department of Health's Office of Youth Violence Prevention. John Comer of Communities United and Baltimore City Health Department, discussed mobilizing communities to take charge of their own healing from community trauma.

Trustworthiness and Transparency: Handle with Care

This webinar provided innovative best practices for helping to mitigate the negative effects experienced by children's exposure to trauma and highlighted a promising initiative (Handle with Care) between schools, law enforcement and treatment providers. Handle with Care, provides the school with a "heads up" when a child has been identified by law enforcement at the scene of a traumatic event. Schools are responding with interventions to help mitigate the trauma and mental health providers are co-locating at the school to provide services. Handle with Care programs promote safe and supportive homes, schools, and communities that protect children, and help traumatized children heal and thrive. Andrea Darr, Director, West Virginia (WV) Center for Children's Justice, WV State Police, Crimes Against Children Unit, and Lt. Chad Napier, Prevention Resource Coordinator for Appalachia High Intensity Drug Trafficking Area for West Virginia and Virginia, presented on this unique collaboration between the educational system and law enforcement and provided guidance for replication for interested communities.
