Following full disclosure of a possible conflict of interest, the BOD shall determine whether a conflict of interest exists and, if so the board shall note to authorize or reject the transaction or take any other action deemed necessary to address the conflict. An interested board member, officer, or employee shall not participate in any discussion or debate of the BOD, or of any committee or subcommittee thereof in which the subject discussion is a contract, transaction, or situation in which there may be a perceived or actual conflict of interest.
